## MOUNT PLEASANT OPTIMISATION PROJECT - COMMUNITY INFORMATION SESSIONS



MACH Energy has prepared a comprehensive Environmental Impact Statement (EIS) for the Mount Pleasant Optimisation Project (the Project).

The Project proposes extraction of additional coal reserves within Mount Pleasant Operation Mining Leases (MLs) and an increase in the rate of coal extraction, without significantly increasing the total disturbance footprint (Figure 1 - see reverse).

#### **Environmental Impact Statement**

The EIS considers the potential environmental impacts of the Project in accordance with the Environmental Assessment Requirements issued by the NSW Department of Planning, Industry and Environment.

It is anticipated that the NSW Government will place the Project EIS on public exhibition in the first quarter of 2021.



#### The EIS will outline:

- a detailed description of the Project;
- an assessment of potential impacts;
- continuation of existing Mount Pleasant Operation environmental management measures; and
- an evaluation of the merits of the Project.

The NSW Minister for Planning and Public Spaces, or the Independent Planning Commission will determine whether the Project can proceed.

MACH Energy encourages all interested people to be involved by making a submission on the Project.
